### **Trustee Zone 5:**

A tract of land situated in the Wilder School District No. 133, Canyon County, Idaho, described as follows:

BEGINNING at the intersection of Batt Corner Road and Fern Road;  
Thence southerly along Batt Corner Road to Sunshine Avenue;  
Thence easterly along Sunshine Avenue to Yellow Rose Street;  
Thence southerly along Yellow Rose Street to Karn Avenue;  
Thence easterly along Karn Avenue to Red Rose Street;  
Thence northerly along Red Rose Street to Prince Avenue;  
Thence easterly along Prince Avenue to US Highway 95;  
Thence southerly along US Highway 95 to Lower Pleasant Ridge Road;  
Thence westerly along Lower Pleasant Ridge Road to Batt Corner Road;  
Thence northerly along Batt Corner Road to Stewart Lane;  
Thence westerly along Stewart Lane to Fargo Road;  
Thence southerly along Fargo Road to Lower Pleasant Ridge Road;  
Thence westerly along Lower Pleasant Ridge Road to Fish Road;  
Thence northerly along Fish Road to Peckham Road;  
Thence Westerly along Peckham Road to a point where the district boundary heads north;  
Thence northeasterly along the district boundary;  
Thence easterly and southerly along the district boundary to an angle point in the district boundary which roughly intersects the northerly extension of Travis Road;  
Thence southerly along Travis Road and the northerly extension thereof to Fern Lane;  
Thence westerly along Fern Lane to the POINT OF BEGINNING.

RESOLUTION NO. 18-142

**A RESOLUTION OF THE CANYON COUNTY BOARD OF COUNTY COMMISSIONERS APPOINTING A SUCCESSOR TRUSTEE TO THE BOARD OF TRUSTEES FOR THE WILDER SCHOOL DISTRICT**

The following resolution and order was considered and adopted by the Canyon County, Idaho Board of Commissioners ("Board") on this 27th day of August, 2018.

Upon the motion of Commissioner Rule and the second by Commissioner White, the Board resolves as follows:

**WHEREAS**, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

**WHEREAS**, Idaho Code § 31-828 grants the Board authority "to do and perform all other acts . . . which may be necessary to the full discharge of the duties of the chief executive authority of the county government"; and

**WHEREAS**, pursuant to Idaho Code § 33-504 the Board is duly empowered to make appointments to fill vacancies on the board of trustees for school district's situated within the County if such appointment is not otherwise made after one hundred twenty days (120) from a declaration of vacancy; and

**WHEREAS**, on March 21, 2018, the Wilder School District Board of Trustees ("School Board") declared the office of the Zone V Trustee vacant due to the resignation of Zone V Trustee Christy Taylor; and

**WHEREAS**, the School Board posted the notice of vacancy in its regular posting places and interviewed two candidates for the office on August 21, 2018; and

**WHEREAS**, the School Board having verified that applicant DeAngelo Enrico is both legally qualified to hold the office of school trustee and meets the residency requirement for the office of Zone V Trustee has recommended his appointment to the office; and

**NOW THEREFORE, THE BOARD HEREBY RESOLVES** that, more than one hundred and twenty (120) days having passed since the notice of vacancy for the office of Wilder School District Zone V Trustee, the Board is duly empowered to make an appointment to the office to fulfill the balance of the unexpired term of Trustee Taylor.

**IT IS FURTHER RESOLVED BY THE BOARD** that, based upon the recommendation of the School Board and assurance from the School Board that the candidate meets the legal requirements to hold the office, DeAngelo Enrico is hereby appointment to the




